5. **The poster sessions have a designated time in which the poster presenters are requested to set up, to be available at their poster to discuss their research with the annual meeting attendees and to tear down.**

### **Poster Preparation**

Abstracts scheduled for presentation in poster sessions will be grouped, numbered and listed in the program and published as an abstract in the conference Proceedings. The poster board is double-sided with one presentation on each side. Your assigned number will be in the upper left hand corner of the poster board. The boards will be arranged in numerical order in the exhibit hall. The poster board surface is approximately 4 feet high and 8 feet wide.

All illustrations should be made in advance. Bear in mind that your illustrations will be read from a distance of about 3 feet or more. Charts, drawings and illustrations might be similar to those you would use in making slides - simple and bold. Readability is the key. Do not mount your illustrations on heavy board because they will be difficult to keep in position on the poster boards. Information should be typed in a large typeface. Keep illustrative material simple.
