The abstract should be listed as follows: Biomarkers of tobacco exposure can be used to evaluate tobacco product toxicity and characteristics, including their potential to cause dependence, morbidity, and mortality in those who use them. Research on the toxicity of electronic nicotine delivery systems (ENDS) use has largely found that ENDS use results in more exposure to substances including nicotine, NNAL (a carcinogenic tobacco specific nitrosamine), and acrylonitrile (a volatile organic compound respiratory toxicant) compared to non-use, but less exposure than conventional cigarette use or dual use. This symposium will present an introduction on the Population Assessment of Tobacco and Health (PATH) Study biospecimens and biomarkers, as well as analyses from five studies utilizing PATH Study data from 2013-2019; these studies use cross-sectional and longitudinal biomarker of exposure and potential harm data from youth and adults who use ENDS exclusively or with cigarettes or other tobacco products. The PATH Study is a nationally representative, longitudinal cohort study of approximately 46,000 youth (ages 12-17) and adults (ages 18+) with a subset of respondents who provided biospecimens that were analyzed for biomarkers of tobacco exposure (e.g., cotinine, total nicotine equivalents, tobacco specific nitrosamines, volatile organic compounds, etc.) and biomarkers of potential harm (e.g., biomarkers of inflammation, such as high sensitivity C-Reactive Protein, and Interleukin-6). This symposium will use all waves of PATH Study biomarker data currently available (Wave 1 [2013/2014] - Wave 5 [2018/2019]). Specifically, this symposium will highlight research that examines: (1) Perceived nicotine content among youth and young adults who currently use ENDS (2018/2019); (2) Tobacco use characteristics associated with nicotine exposure among youth and young adults who use ENDS alone or with cigarettes (2018/2019); (3) Biomarkers of exposure by ENDS device type among adults who exclusively use ENDS (2018/2019); (4) Characteristics that impact changes in nicotine exposure among adults who use ENDS alone or with cigarettes (2013-2019); (5) Relationship between biomarkers of exposure and biomarkers of potential harm among adults who use tobacco, including ENDS (2013/2014). Dr. David Ashley will serve as Symposium Discussant to summarize the PATH Study research presented as well as implications for tobacco research in the U.S. and internationally.
